### Director Independence

The Board recognises the valuable contribution that independent Directors bring to good corporate governance. All Directors, whether independent or not, are required to act in the best interests of the Company and to exercise unfettered and independent judgment.

The Board regularly reviews the independence of each Non-Executive Director. The Board assesses the independence of new Directors upon appointment and reviews their independence, and the independence of the other Directors, annually and as appropriate.

The Board considers that an independent Director is a Non-Executive Director who is free of any interest, position, association or relationship that could influence, or reasonably be perceived to influence, in a material respect the Director's capacity to bring an independent judgement to bear on issues before the Board and to act in the best interests of the Company and its shareholders generally.

When assessing the independence of a Director, the Board considers the matters potentially affecting the independent status of a Director as described in Box 2.3 of the Principles and Recommendations.

The Board may determine that a Director is independent notwithstanding the existence of an interest, position, association or relationship of the kind described in Box 2.3 of the Principles and Recommendations. However, in such a case, the Board will disclose the reasons for making its determination.

If at any time during the year a Director ceases or may have ceased to be independent, they are required to advise the Chairman immediately and a change in a Director's independent status will be disclosed and explained to the market in a timely fashion.

The Board has reviewed the position and relationships of all Directors in office as at the date of our 2023 Annual Report and considers that four of the five Directors are independent.

Mr Ross, the Managing Director, is not considered by the Board to be independent as he is currently employed in an executive capacity by the Company, and receives performance-based remuneration from, and may participate in, the Company's employee incentive schemes from time to time.

Despite Mr Heng's 11-year tenure as a Non-Executive Director of the Company, the Board (excluding Mr Heng) has reviewed his position and considers that Mr Heng remains an independent director. During his tenure Mr Heng has always adhered to good corporate governance practices and always acted impartially (without influence from management or other stakeholders). The Board considers that Mr Heng's deep understanding of the Company's operations and history and the industry generally allow him to provide valuable insights to the Board, for the benefit of the Company.

All Directors have unrestricted access to employees of the Company and, subject to the law, access to all Company records and information held by the Company and its external advisers. In addition to presentations by Senior Management at Board meetings, Directors may seek briefings from Senior Management on specific matters.

Each Director, the Board and the Board Committees may obtain independent professional advice at the Company's expense, as considered reasonable and necessary, subject to prior approval of the Chairman.

Directors are entitled to reimbursement of all reasonable costs in obtaining such independent professional advice which has been approved by the Chairman. In the case of a request made by the Chairman, approval is required from the Chair of the Audit and Risk Committee.

Company performance and market remuneration. Other than statutory superannuation, Directors are not entitled to retirement allowances.

During the reporting period the Company developed a policy regarding minimum shareholding requirements for its Non-Executive Directors. The policy requires Non-Executive Directors to acquire and hold a minimum shareholding in the Company with a value equal to 100% of the Non-Executive Director's base fee (excluding superannuation and committee fees) in a given financial year. Non-Executive Directors must meet the minimum shareholding within 5 years after the Non-Executive Director's appointment.

The Company will continue to review and report on the performance of the Non-Executive Directors against the policy.

Our Managing Director and senior executives are generally remunerated by way of a fixed annual remuneration component and an incentive or "at risk" remuneration component. The incentive or "at risk" remuneration component comprises both a short-term and long-term incentive. The mix of remuneration components and the measures of performance used in the incentive plans are chosen by the Board to ensure that there is a strong link between remuneration, senior executive performance and sustainable Company performance to increase shareholder value.

Senior executives who have an incentive or "at risk" component to their total remuneration packages, have defined performance conditions which are set at the start of the financial year (in the case of the annual short-term incentive plans) or at the commencement of the plan (in the case of the long-term incentive plans).

Having regard to the overall performance of the Company during the 2023 financial year and current market conditions, the key remuneration outcomes for the Company's key management personnel in the 2023 financial year were as follows:

#### Fixed Annual Remuneration (FAR)

- For the 2023 financial year the Managing Director and other executive key management personnel received a 4% increase in their FAR having regard to market conditions and inflation.

#### Short-term Incentives (STI)

##### *FY2023 STI Performance Incentive*

- The Board issued an FY2023 STIP to the Managing Director, executive key management personnel and other senior managers for the 2023 financial year. The FY2023 STIP was payable either in cash or shares at the absolute discretion of the Board (subject to targets being achieved).
- At the Company's 2022 Annual General Meeting the Company's Shareholders approved (by a clear majority) the issue of up to



647,751 FY2023 STIP Performance Rights to the Managing Director (subject to the targets being achieved and the Board exercising its discretion to issue the FY2023 STIP in shares). As disclosed in the Explanatory Memorandum to the Notice of Meeting, the Company prescribed a value of \$0.578 for each FY2023 STIP performance right – being the 30-day volume weighted average price of the Company’s shares up to the commencement of the performance period for the FY2023 STIP (being 1 July 2022).

- The performance criteria for the FY2023 STIP related to:
  - Group EBIT Targets (80% weighting) - set ensure that the remuneration of key management personnel is directly linked to the achievement of positive financial returns for the business; and
  - Group Safety Targets (20% weighting) - set to ensure that key management personnel continue to prioritise safety in all aspects of the Company’s operations and business.
- Pleasingly the Group Safety Targets were achieved and further, given the Company’s solid performance for the 2023 financial year, the Group EBIT targets were exceeded. As a result the executive key management personnel achieved the maximum FY2023 STIP entitlement.
- Having exercised its discretion, the Board has decided that for the Managing Director and executive key management personnel the FY2023 STIP would take the form of performance rights (which are not yet issued) which will convert into an ordinary, fully paid shares in the Company upon completion of an additional 12-months of service by the participant (i.e. they will vest on 1 July 2024). The Board considered that the deferred vesting of these performance rights provides the Company with an additional retention benefit with respect to the key management personnel.

Long-term Incentive (LTI)

*FY2023 LTI Performance Rights*

- As previously reported and recognising the need to retain and suitably incentivise the Managing Director and other key personnel (in the interests of the Company and all its shareholders), the Board has determined to continue the LTI component for the Managing Director and other Senior Management for the 2023 financial year.
- The Board issued an FY2023 LTIP for the Managing Director and key management personnel for the 2023 financial year.
- At the Company’s 2022 Annual General Meeting the Company’s Shareholders approved (by a clear majority) the issue of up to



1,170,246 FY2023 LTIP Performance Rights to the Managing Director (subject to the targets being achieved).

- The FY2023 LTIP Performance Rights have a 3-year performance period (beginning on 1 July 2022 and ending on 30 June 2025).
- Each performance right converts to an ordinary, fully paid share in the Company upon vesting.
- As disclosed in the Explanatory Memorandum to the Notice of Meeting, the Company prescribed a value of \$0.58 for each FY2023 LTIP performance right contingent upon retention and a value of \$0.354 for each FY2023 LTIP performance right contingent upon the share price hurdle. This is the fair value of the performance rights at the beginning of the FY2023 LTIP performance period (1 July 2022) as calculated by an independent valuation firm.

For the Managing Director and other key management personnel, the FY2023 LTI Performance Rights included the following performance hurdles:

- **Share Price Target** (87% weighting) – with (1) 60% vesting if Company's share price is equal to \$0.75 at 30 June 2025; (2) Pro-rata vesting (on a straight-line basis) if Company's share price is greater than \$0.75 but less than \$1.05 at 30 June 2025; and (3) 100% vesting if Company's share price is \$1.05 or greater at 30 June; and
- A **Retention Hurdle** (13% weighting) if the employee remains employed by the Company (or a wholly owned subsidiary of the Company) on 30 June 2025.

#### Managing Director Retention Incentive

- In order to mitigate against the disruption that can result from key personnel turnover, the Board felt it appropriate to introduce a retention incentive package for the Managing Director in order to incentivise the Managing Director to remain with the Company and further deliver on the Company's strategy.
- At the Company's 2022 Annual General Meeting the Company's Shareholders approved (by a clear majority) the issue of up to 628,188 Retention Incentive Performance Rights to the Managing Director (subject to the retention condition being met and the Board exercising its discretion to issue the retention incentive in shares). As disclosed in the Explanatory Memorandum to the Notice of Meeting, the Company prescribed a value of \$0.596 for each retention performance right – being the 30-day volume weighted average price of the Company's shares up to the date the Board resolved to issue the retention performance rights to Mr Ross.
